Right of Way Agreement

THIS RIGHT OF WAY AGREEMENT, is made and entered into as of this ____ day of _____, _____, by and between

COUNTY OF SURRY

("GRANTOR") and VIRGINIA ELECTRIC AND POWER COMPANY, a Virginia public service corporation, doing business in Virginia as Dominion Energy Virginia, with its principal office in Richmond, Virginia ("GRANTEE").

WITNESSETH:

1. That for and in consideration of the mutual covenants and agreements herein contained and other good and valuable consideration, the receipt and sufficiency whereof is hereby acknowledged, **GRANTOR** grants and conveys unto **GRANTEE**, its successors and assigns, the perpetual right, privilege and non-exclusive easement over, under, through, upon, above and across the property described herein, for the purpose of transmitting and distributing electric power by one or more circuits; for its own internal telephone and other internal communication purposes directly related to or incidental to the generation, distribution, and transmission of electricity, including the wires and facilities of any other public service company in aid of or to effectuate such internal telephone or other internal communication purposes; and for lighting purposes; including but not limited to the right:

1.1 to lay, construct, operate and maintain one or more lines of underground conduits and cables including, without limitation, one or more lighting supports and lighting fixtures as **GRANTEE** may from time to time determine, and all wires, conduits, cables, transformers, transformer enclosures, concrete pads, manholes, handholes, connection boxes, accessories and appurtenances desirable in connection therewith; the width of said non-exclusive easement shall extend fifteen (15) feet in width across the lands of **GRANTOR**; and

Right of Way Agreement

2. The easement granted herein shall extend across the lands of **GRANTOR** situated in Surry County, Virginia, as more fully described on Plat(s) Numbered 33-20-00101, attached to and made a part of this Right of Way Agreement; the location of the boundaries of said easement being shown in broken lines on said Plat(s), reference being made thereto for a more particular description thereof.

3. All facilities constructed hereunder shall remain the property of **GRANTEE**. **GRANTEE** shall have the right to inspect, reconstruct, remove, repair, improve, relocate on and within the easement area, including but not limited to the airspace above the property controlled by **GRANTOR**, and make such changes, alterations, substitutions, additions to or extensions of its facilities as **GRANTEE** may from time to time deem advisable.

4. **GRANTEE** shall have the right to keep the easement clear of all buildings, structures, trees, roots, undergrowth and other obstructions which would interfere with its exercise of the rights granted hereunder, including, without limitation, the right to trim, top, retrim, retop, cut and keep clear any trees or brush inside and outside the boundaries of the easement that may endanger the safe and proper operation of its facilities. All trees and limbs cut by **GRANTEE** shall remain the property of **GRANTOR**.

5. For the purpose of exercising the right granted herein, **GRANTEE** shall have the right of ingress to and egress from this easement over such private roads as may now or hereafter exist on the property of **GRANTOR**. The right, however, is reserved to **GRANTOR** to shift, relocate, close or abandon such private roads at any time. If there are no public or private roads reasonably convenient to the easement, **GRANTEE** shall have such right of ingress and egress over the lands of **GRANTOR** adjacent to the easement. **GRANTEE** shall exercise such rights in such manner as shall occasion the least practicable damage and inconvenience to **GRANTOR**.

6. **GRANTEE** shall repair damage to roads, fences, or other improvements (a) inside the boundaries of the easement (subject, however, to **GRANTEE**'s rights set forth in Paragraph 4 of this Right of Way Agreement) and (b) outside the boundaries of the easement and shall repair or pay **GRANTOR**, at **GRANTEE**'s option, for other damage done to **GRANTOR**'s property inside the boundaries of the easement (subject, however, to **GRANTEE**'s rights set forth in Paragraph 4 of this Right of Way Agreement) and outside the boundaries of the easement caused by **GRANTEE** in the process of the construction, inspection, and maintenance of **GRANTEE**'s facilities, or in the exercise of its right of ingress and egress; provided **GRANTOR** gives written notice thereof to **GRANTEE** within sixty (60) days after such damage occurs.

Right of Way Agreement

7. **GRANTOR**, its successors and assigns, may use the easement for any reasonable purpose not inconsistent with the rights hereby granted, provided such use does not interfere with **GRANTEE**'s exercise of any of its rights hereunder. **GRANTOR** shall not have the right to construct any building, structure, or other above ground obstruction on the easement; provided, however, **GRANTOR** may construct on the easement fences, landscaping (subject, however, to **GRANTEE**'s rights in Paragraph 4 of this Right of Way Agreement), paving, sidewalks, curbing, gutters, street signs, and below ground obstructions as long as said fences, landscaping, paving, sidewalks, curbing, gutters, street signs, and below ground obstructions do not interfere with **GRANTEE**'s exercise of any of its rights granted hereunder. In the event such use does interfere with **GRANTEE**'s exercise of any of its rights granted hereunder, **GRANTEE** may, in its reasonable discretion, relocate such facilities as may be practicable to a new site designated by **GRANTOR** and acceptable to **GRANTEE**. In the event any such facilities are so relocated, **GRANTOR** shall reimburse **GRANTEE** for the cost thereof and convey to **GRANTEE** an equivalent easement at the new site.

This Exhibit A shall be attached to and made a part of the RIGHT OF WAY AGREEMENT executed by the undersigned **GRANTOR(s)** on the _____ day of _____, 20____. In addition to the agreements within the attached RIGHT OF WAY AGREEMENT:

1. **GRANTOR** grants and conveys unto **GRANTEE** the perpetual right, privilege and exclusive easement on the property of **GRANTOR** within the existing easement created by this RIGHT OF WAY AGREEMENT, for the delivery of communications services, (the "Communication Easement") which shall include the right to:
 - 1.1 Attach, operate, and maintain, additional cables, including but not limited to fiber optic cables, wires, attachments, and other transmission facilities as **GRANTEE** may from time to time deem advisable, and all equipment, accessories and appurtenances desirable in connection therewith, including the right to increase or decrease the number of wires, all for the purpose of transmitting voice, text, data, internet services, and other communications services, including the wires and attachments of third parties (the "Communication Rights");
 - 1.2 Apportion, lease, or license such Communication Rights in whole or in part to third parties as may be useful or practical, including the rights to transmit third party data and the right to apportion, lease, or license surplus communications capacity to third parties for the exercise of Communication Rights; and
 - 1.3 Install such additional pole, guys, and anchors on said property as may be necessary for purposes of the safety and stability of the communication facilities.
2. The Communication Easement granted hereby shall not be interpreted or construed to convey to **GRANTEE** the right to construct an additional pole line upon the lands of **GRANTOR**.

THIS RIGHT OF WAY AGREEMENT dated _____, 20____, by and between the
COUNTY OF SURRY

a political subdivision of the Commonwealth of Virginia ("**GRANTOR**"), and VIRGINIA ELECTRIC AND POWER COMPANY, a Virginia public service corporation doing business in Virginia as Dominion Energy Virginia ("**GRANTEE**") is hereby amended as follows:

1. This Right of Way Agreement shall be limited in duration and shall remain in force for a term of forty (40) years, except for any air rights together with easements for columns for support granted hereunder, in which case such air rights together with easements for columns for support shall exist for a term of sixty (60) years. At the end of any such term, this Right of Way Agreement shall automatically terminate unless **GRANTOR** agrees to renew this Right of Way Agreement for an additional term of years.
2. In the event that this Right of Way Agreement is terminated, or if the removal of **GRANTEE**'s facilities is otherwise desired by **GRANTOR**, then **GRANTOR** agrees that it will pay the cost of removing **GRANTEE**'s wires and facilities, and, if appropriate, the cost of replacing **GRANTEE**'s wires and facilities. Upon the termination of this Right of Way Agreement, **GRANTOR** agrees to provide **GRANTEE**, if needed by **GRANTEE**, a suitable substitute easement subject to the same terms provided for herein for **GRANTEE**'s wires and facilities. In the event that this Right of Way Agreement is revoked or terminated, all facilities constructed hereunder shall remain the property of **GRANTEE**.
3. **GRANTOR** covenants that in the event that **GRANTOR** sells or conveys the real property on which **GRANTEE**'s wires and facilities are located by this Right of Way Agreement, **GRANTOR** will provide **GRANTEE** with a suitable permanent easement for **GRANTEE**'s wires and facilities and, if necessary, pay the cost of relocating **GRANTEE**'s wires and facilities to such permanent easement.

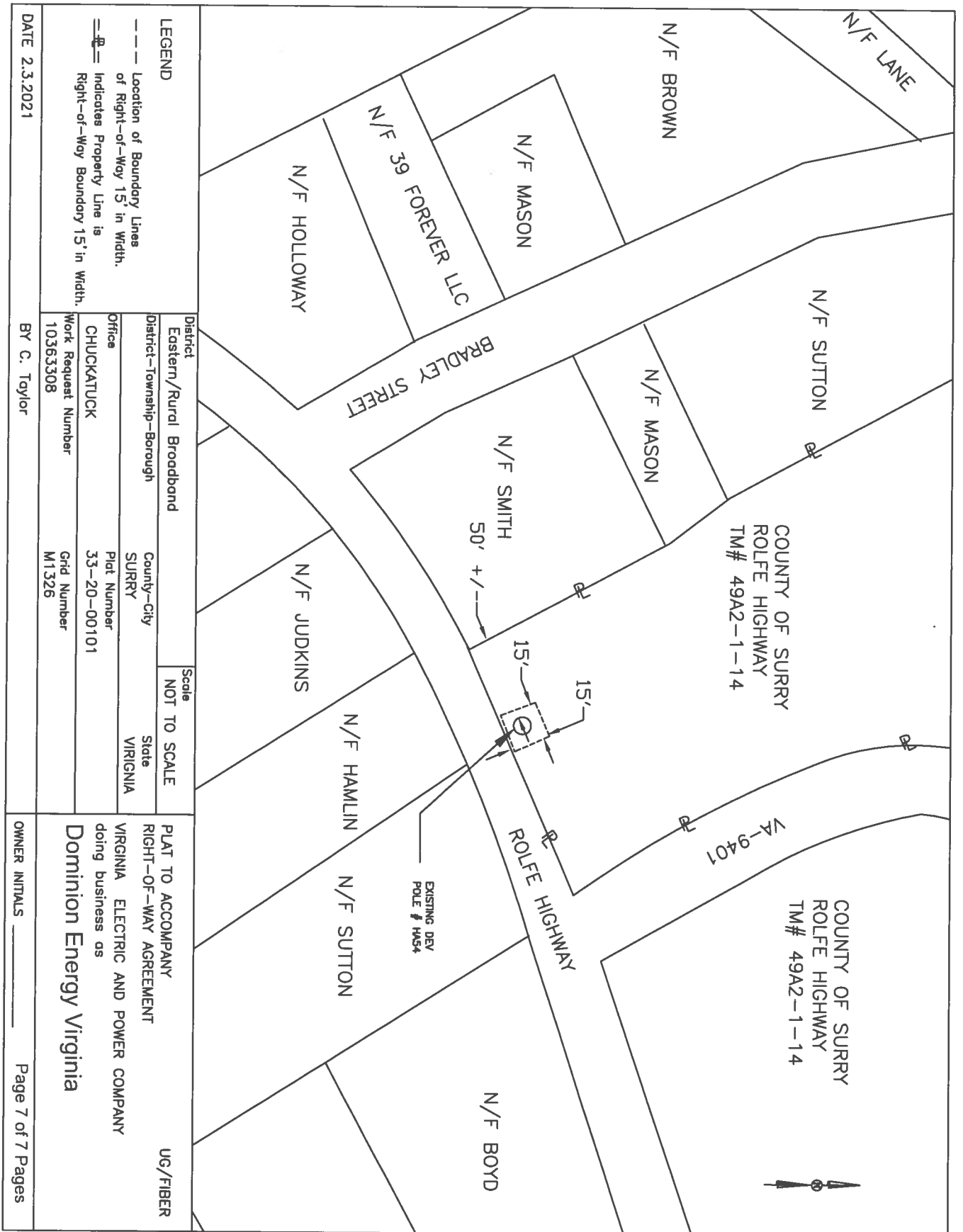

INNOVATIVENESS

Surry County, VA, like most rural counties in America, was lacking high-speed internet access to citizens and business. Private Internet Service Providers (ISP) struggle to fill the gaps in rural America due to the massive amounts of fiber and infrastructure needed to reach businesses and homes. Surry is a 279 square mile rural community with a population of 6,523 and a median household income of \$57,962 per the U.S. Census ACS 2019.

After Surry County was denied a VATI grant in 2017, having very few opportunities for high-speed internet access grants and witnessing the amount of success Prince George County and Prince George Electric Cooperative (PGEC) had in their private/public partnership, leadership decided to

approach the cooperative on this innovative approach. In August of 2020, the County and PGEC signed a Memorandum of Understanding that would give 100% of Surry County residents internet access via broadband or existing wireless infrastructure.



Innovation for this project comes from the risk our county had to take in committing to the public/private partnership with PGEC. Big projects such as Fiber-To-The-Home (FTTH) deals with a large amount of taxpayer dollars in which needed citizen support and trust in the private partner. Surry County leadership did not want to create a broadband

authority and did not want to accept gains or losses of project and increase or involve County staff in daily operations of being an ISP.

TRANSFERABILITY

The Surry County and PGEC public/private FTTH project can be implemented in most cooperative areas (majority rural areas) by those cooperatives taking on this pilot program. The County decided to partner with a local entity that it has known and trusted for decades, the local electric cooperative - PGEC. This is the long-term solution for internet in rural America: appropriate cost, last



mile fiber, start small and build the business with the users, construction of fiber lines to support

cooperative electric operations and supplies fiber to the home for the same electric customers and businesses.

When private ISPs refused to provide internet services to our rural community, the Cooperative and the County took matters into their own hands and began the process of rolling out a fiber network. The fiber subsidiary created by PGEC, PGEC Enterprises, LLC, is undercapitalized in order to build FTTH connections in the rural community due to the distances between residents and businesses.

COMMUNITY COMMITMENT AND LEVERAGE

Surry County was awarded in the form of a grant through the Virginia Telecommunications Initiative, \$2.25 million to provide broadband service to 1,253 homes. The VATI program is state-funded and administered by the Virginia Department of Housing and Community Development (DHCD). It provides targeted funding to extend service to areas that are unserved by a broadband provider and go to localities and broadband authorities to provide “last-mile” fiber to unserved communities.



In addition to the state VATI funding, PGEC Enterprises, LLC, received Connect American Funding (CAF) to deploy in all additional areas of Surry County. The completion of the FTTH project will mean all Surry residents will have broadband available to each home in the county.

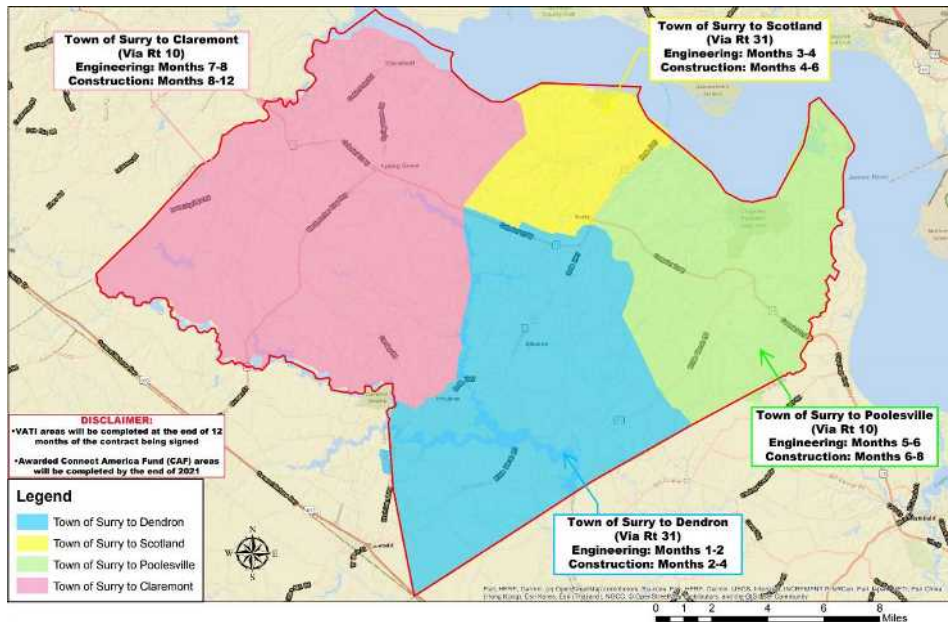
Permitting will be completed on a case-by-case basis, currently PGEC Enterprises, LLC works under an active blanket land use permit with Virginia Department of Transportation (VDOT) that

will remain active throughout the duration of the project. Additionally, Surry County has a resolution permitting county projects within the VDOT Right-Of-Way.

MEASURED OBJECTIVES

Surry County leadership established a result driven program with PGEC by committing to a phased-out approach. PGEC provides documentation to the County monthly verifying pending applications, homes/businesses connected, poles replaced, miles of fiber and number of new applications.

Please see the graphs below highlighting Phases and Fiber buildout.

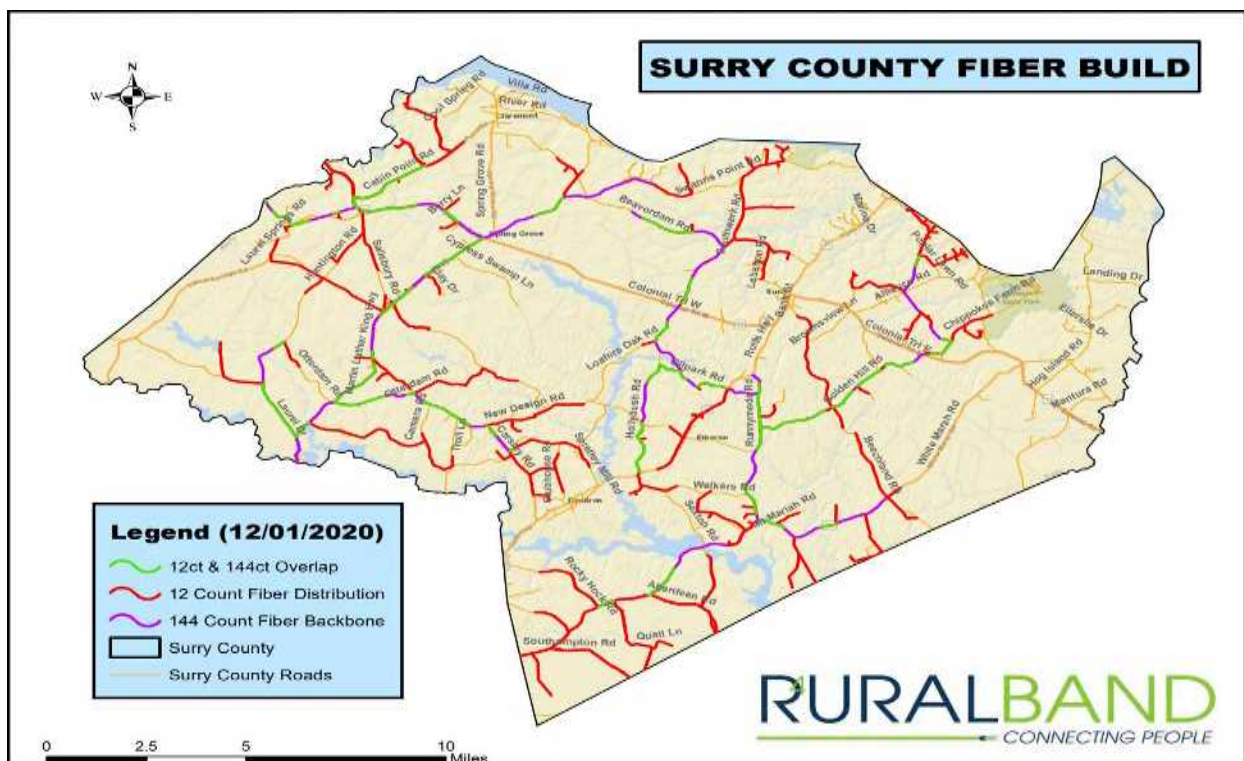


Phase 1: FTTH project, Town of Surry to Dendron, entailed PGE connects 250 residents/businesses for \$500,000.

Phase 2: FTTH project, Town of Surry to Scotland, entailed another 250 residents and business connections for \$500,000.

Phase 3-4: consisting of making the

remainder deprived areas of the county available to broadband connections with VATI funding with County match totaling \$4,450,000. The County established a final agreement with PGE committing to provide the availability of high-speed broadband internet access to 100% of Surry County residents.



SECONDARY BENEFITS

The COVID-19 Pandemic has given the County and our citizens unprecedented obstacles. The pandemic has forced many of our residents and students working and learning from home. As of December 2020, PGEC has reported to the county that there have been 601 homes connected, 447 poles replaced, 260 miles of fiber constructed with 77 pending applications. The County and PGEC has received great feedback on how this has helped our citizens with their employment, schooling for children and those in higher education, and telehealth.

PGEC in collaboration with the County has provided our citizens with a Community Learning Room and established a hotspot for citizens to drive up to the center and have access in the parking lot at the Parks and Recreation Community Center. The Farmers Market Pavilion and the Surry County Sheriff's Office are also hotspots opening opportunities for those that are deprived of high-speed internet access.

In conclusion, the Surry County and Prince George Electric Cooperative public/private partnership in establishing Fiber-to-the-Home availability to all of our citizens is a highly impactful community development project that is and will better our citizen's quality of life and spruce economic development.

What's New This Week

The [Vaccine Summary Dashboard](#) continues to show Virginia's significant progress in vaccinations, with **more than 1.6 million doses administered**. Although last week's severe winter weather delayed vaccine shipments to Virginia, **more than 9 in 10 of available first doses have been administered**. (It is important to note that the number of doses shown as being "received" by hospitals and local health districts does not account for the doses they then redistribute to other partners such as physicians and pharmacies.)

The **statewide vaccine pre-registration system** at vaccinate.virginia.gov has received more than 518,000 pre-registrations since its launch on February 15. Including individuals who pre-registered through local health districts in the past, the new system now includes nearly 1.7 million residents and essential workers. **All individuals who have previously filled out a survey or form or signed up for a waitlist to be vaccinated through their local health district have been automatically imported into the new statewide system and do not need to pre-register again.** As data migration continues, some pre-registrations may not yet appear in the search tool. Anyone who experiences difficulties with the search function should check the spelling of their name and email address carefully and consider whether they may have used a different name, phone number, or email address in the past. Anyone with questions should call 877-VAX-IN-VA rather than their local health district. A [public information toolkit](#) is available to assist local health districts, localities, and community partners with graphics, talking points, frequently asked questions, and other materials.

The new central Vaccinate Virginia phone number, **877-VAX-IN-VA** (877-829-4682), has received more than 115,000 calls so far, and is available seven days a week, from 8 a.m. to 8 p.m. Service is available immediately in **English and Spanish**, with real-time interpreter services available in any of more than 100 languages as needed.

Based on our population, Virginia is now receiving approximately 161,000 doses per week from the federal government. There are still simply not enough doses available yet for everyone who is eligible to receive them. Virginia is not likely to meet the demand for Phase 1b until March or April. Unfortunately, it may be weeks or longer before vaccination appointments become available for those who have pre-registered.

As part of a **federal retail pharmacy program**, 140 pharmacy locations in Virginia are now receiving a total of 52,000 new first doses per week beyond Virginia's normal allocation. Participating locations include CVS, Food City, Giant, Kroger/Harris Teeter, Safeway, Walgreens, Walmart, and multiple independent community pharmacies. The Commonwealth is working with these pharmacies to ensure that as many appointments as possible are offered first to people age 65 and older who are currently on local health district waitlists, rather than accepting new signups from the general public. Unfortunately, CVS has been unable to find a way to do this within the technical limits of their appointment system. Anyone 65 or older can check [cvs.com](https://www.cvs.com) regularly as appointments become available.

Governor Northam has [amended Executive Order 72](#) to **expand opportunities for outdoor activities** in light of improving COVID-19 case statistics. While **limits on indoor gatherings remain the same** (including a limit of 10 people at indoor social gatherings), the limit on outdoor social gatherings and exercise groups will increase to 25 people and the limit on outdoor racetrack and amusement venues will increase to 1,000 people. The amended order removes the stay-at-home order from midnight to 5 a.m. and extends the cutoff time for alcohol sales in restaurant dining rooms from 10 p.m. to midnight. These amendments, which will be effective March 1, follow the recent amendment in effect as of February 22 to increase the capacity limit for outdoor recreational sporting events to 250 spectators. Summer camps will be able to open as of May 1, using strict mitigation protocols such as small cohorts of campers. Key Overview Points

The doses Virginia receives from the federal government are **allocated by the Virginia Department of Health to local health districts**, primarily in proportion to each district's population. Local health districts are expected to determine the most equitable and efficient use of each allocation, leveraging any combination of their own staff and volunteers, hospitals, pharmacies, and individual providers. Additional doses help support targeted equity initiatives. Other doses reach some residents of Virginia through separate federal allocations for employees of the U.S. Department of Defense and certain other

agencies; the Indian Health Service; and a federal contract to vaccinate residents of long-term care facilities.

All local health districts in Virginia are in [Phase 1b of vaccine eligibility](#). This means that approximately 50% of Virginia's population is now eligible, including frontline essential workers, people aged 65 years and older, people with high-risk medical conditions identified by the CDC, and people living in correctional facilities, homeless shelters, and migrant labor camps. Other than the healthcare workers and residents of long-term care facilities in Phase 1a, the Virginians in Phase 1b are at the highest risk of exposure to COVID-19 or serious illness if infected.

While local health districts are allowed flexibility in how doses are administered to eligible individuals, **roughly half of the available supply should be used for people aged 65 or older.** The other half should be used for frontline essential workers, people with high-risk medical conditions as [identified by the CDC](#); and people in correctional facilities, homeless shelters, and migrant labor camps. Frontline essential workers should be prioritized in the order listed in the [Phase 1b details](#).

Anyone who receives the first dose of vaccine will receive the second dose three or four weeks later as appropriate. Vaccine providers should not hold back their current first dose supply for second doses; they will receive second doses in proportion to the first doses they administer.

[Executive Order 72](#) maintains the 10-person limit on social gatherings, the requirement to wear masks in public places, guidelines for businesses, and other provisions. It is essential to continue these mitigation strategies even by people who are vaccinated.

How Localities Can Help

Support local health departments by ensuring that pre-registration options through vaccinate.virginia.gov and 877-VAX-IN-VA are promoted through local websites and other channels.

Emphasize to the public that because approximately 50% of Virginia residents are now eligible to be vaccinated, the limited supply of vaccine from the federal government means **it will take weeks or longer to complete Phase 1b** unless supply improves.

Closely coordinate with local health districts to **plan smaller vaccination clinics now and larger ones once supply improves.** Pooling venues, staff, volunteers, and other resources now will avoid delays later.

Remind everyone in the community that **it is more important than ever to take the same precautions as always:** staying home when possible, wearing masks when out, maintaining physical distance from others, washing hands frequently, and other best practices.

Remind everyone to **always look for websites that end with “.gov”** to make sure the information is official. When a vaccine appointment becomes available through a local health district, there will be no charge. State and local agencies will never call, email or text to ask someone for a social security number or immigration status in connection with vaccination.

Library Director's Report January 20, 2021

January was a busy and exciting month for Blackwater Regional Library. While the locally rising cases during the first part of the month was obviously a concern, our talented staff continued to offer contactless take-home programs for patrons of all ages including Storytime to GO or similar kits being available at all locations; facilitated and assisted hundreds of patrons with their technology needs as patrons needed our technology offerings for school, work and everything in between, all while practicing the safety measures required to keep our staff and our community safe. It is also a credit to our talented staff that BRL has also continued to be an innovator in the library community as we were contacted by other public libraries in Virginia asking for information about our STEM-to-go Kits and our recent successful Storywalks.

While we miss seeing our patrons for our programs, we have been fortunate enough to receive some photos from patrons enjoying our resources and “take home” products at home.



Speaking of programming, BRL has continued in the virtual programming realm with Ms. Natalie's Youtube Storytimes, which seemed to be a big hit with patrons across our service area. A thank you to Smithfield/Carrollton programmer **Natalie Kelly** for leading these storytimes, and Carrollton manager, **Megan Wilson** for producing and editing the videos.

We also introduced **Mometrix**, a database that offers career and test prep resources to our patrons free with their Blackwater Regional Library card.



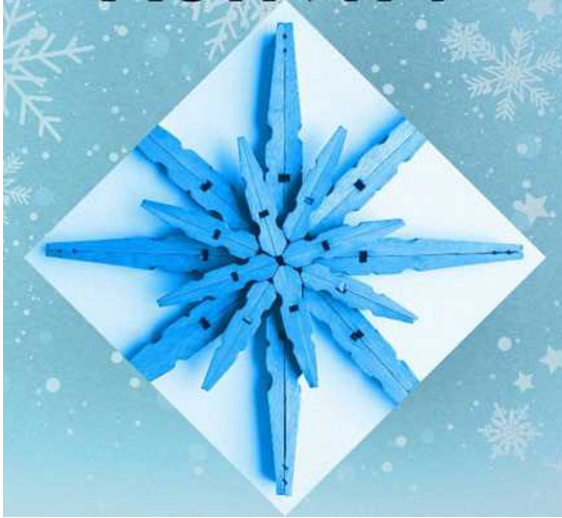
Finally, no January is complete without at least the threat of winter weather. BRL locations operated on a two-hour delay on January 28th due to snow, and the branches with evening hours on that Thursday closed an hour early to permit staff to safely get home before the snow froze back over on the roads.

Location/Localities News:

City of Franklin

The **Franklin** branch had a busy month, where staff promoted their in-house theme of “Traversing Through Time” which promoted historical fiction titles in their collection, created Story Time

on the GO kits (with a snowman/flake theme) for families, For our adults, we prepared “Take & Paint DIY Kits”. Each kit consisted of one glass mason jar, paint, a paintbrush, a tea light, decorative accessories, and the instructions to be as creative as possible. Included is an example to give our patrons some inspiration!



Then for our littlest patrons, we prepared “Storytime on the GO Kits”. For January, the themes consisted of things such as Snowmen and Snowflakes. These kits contained a craft, a coloring sheet, short story, and instructions for the parents!

Staff also prepared “Teen 2 Go” crafts. For January, we had the theme of Snowflakes as well. This was a quick and fun craft, that contained multiple different sized colored clothespins, and instructions with a picture included!

Finally, Bookmobile and Outreach Services staff conducted safe “drop offs” twice in January at The Village at Woods Edge in Franklin. We continue to average 15-20 patrons that materials are curated for during each stop, and the staff at The Village have communicated to BRL staff how much their residents appreciate the time and effort library staff put into selecting the books we send to them!

Isle of Wight County

The **Carrollton** branch programs for January included STEM To-Go kits, Finals Survival Kits, Pre-school Storywalks, and online Romance Book Club. STEM To-Go kits for this month featured a fun building challenge for school-aged kids, while the Finals Survival Kits included sweet treats and words of encouragement for our teen patrons working their way through end-of-semester exams.

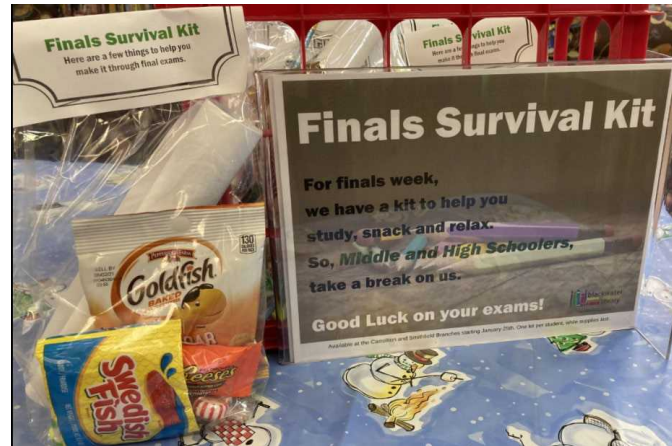
The Carrollton Branch Library Romance Book Club met via Zoom on Thursday, January 28th. Members discussed “The Search,” by Nora Roberts and chat about other books members read during the month. Our Romance Book Club features an online Goodreads community with discussion board and currently meets only via Zoom. This format has allowed us to welcome new participants that were previously not able to attend the in-person discussions. We plan to continue this format after normal programming has resumed.

At the **Smithfield** branch, preschoolers at local daycares and preschools are all being treated to our popular “Community Pop-Up Story Walks” once a month. For slightly older children, we offered our monthly STEM-to-go Kit, which this month featured an engineering tower-building challenge using only spaghetti and marshmallows, and for teens, we offered a relief from the winter exam period with our “Final Exam Survival Kit”. Each kit contained study aids, a

stress relief activity, (and some chocolate and snacks of course!). Nearly 70 combined kits were picked up by area families!



Finally, Smithfield manager, Terry Andrews met with Connie Chapman of Isle of Wight Tourism to plan our partnership activities for upcoming community Story Walks in the Spring, Summer, and Fall in conjunction with the local business community.

The **Windsor** branch has been easing into the New Year with the resumption of our On the Go Storytime and Adult Take and Make Kits. This month seems to be all about snow, with a snow storytime as well as the Take and Make snowflake kit for adults. Since we cannot have a book sale and our book shed is full, we have set up carts of books and other materials that are in search of a new home. Our patrons love it!

With schools back in person, we will be starting our collection deposits and classroom story time kits the beginning of February. We have also been exploring safe options to begin book club and our Hooks and Needles group in the near future. Speaking of the future, Bethany, our Senior Library Assistant, completed a webinar on STE(A)M powered programs for tots to teens and she is excited about incorporating her new ideas into future programs. Overall, our patrons have been very appreciative of the services we are able to offer- computer use, faxing, copies and of course books and movies. We are glad to be able to serve our community!



Our **Bookmobile and Outreach Services** continued their safe deposits of materials at Riverside Healthy Living Community in Smithfield and Consulate Health Care of Windsor on a biweekly basis. Our staff deposited over 150 items in January for residents of these communities to enjoy.

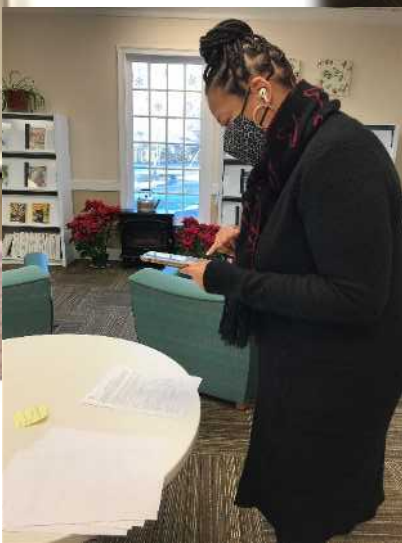
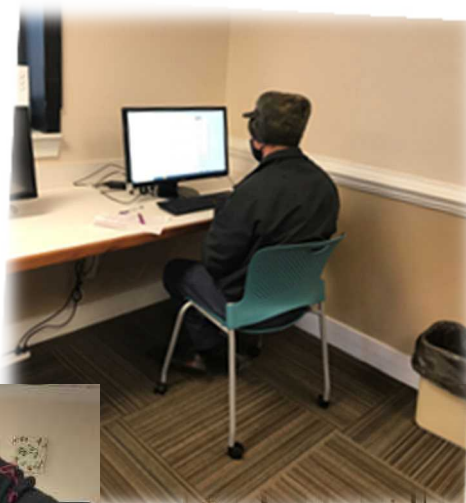

- Media lit offers an opportunity to deflect from sharing your own opinion.
- Be ready to address why the patron thinks their information source is reliable and how that is determined.
- Have resources ready!

In Your Ongoing Programs:

- Book clubs, screenings & discussions, tech classes & makerspace programs

(Relate themes to current events, discuss how media portrays those events & why, ask about related media lit principles)

- Community celebrations (partner with local journalists or other media representatives, host a panel discussion, give patrons the opportunity to learn informally from media experts)

- Displays & Passive Programs (Use displays as a teaching tool, supplement with resources that explain media literacy, use QR codes, virtual options)

1/13/21 – Extreme Customer Service, Every Time – The Extreme Customer Service, Every Time webinar discussed the importance of good customer service and the ways we can provide good service to our patrons. They provided PowerPoint slides, a written recap of the webinar, and the past chat that was available during the live webinar.

Gretchen Caserotti, the Library Director from Meridian Library District in Idaho, led the webinar and discussed ways we can increase the customer service we provide while also sharing experiences and her knowledge of working in library service. She stated that library staff have to want to provide good customer service and that we are the key to putting these practices into action.

Library patrons expect good customer service and Gretchen explained the six core values that will help library staff provide excellent customer service: Convenience, comfort, hospitality, quality, trust, and the WOW factor (or going above and beyond to make a patron happy). She shared examples of real-life stories of excellent customer service and the importance of strengthening the patron base and their loyalty. When a patron experiences excellent customer service, they are more likely to market for you by recommending your library and its services.

In order for staff to want to practice excellent customer service, the library leadership and staff must build trust with each other and find quick resolutions to internal conflicts that may impact their attitude towards patrons. Gretchen also stated that no matter what role a library staff member has in the library, patrons will always perceive them as librarians. This fact is important to note because it helps library staff become prepared to answer patron inquiries relating to tasks they may not always perform.

Time is another important aspect that was discussed. Library staff should be supported by library admin and managers by helping them to learn how to prioritize/balance engaging with patrons and completing their tasks by providing them with training and acknowledging them when they model good attitudes around patrons. Gretchen ended the webinar by stating that there is no set script for extreme customer service. Rather, it is a drive within the library staff to want to assist patrons with what they need while acting in a generous manner. When a staff member embraces the willingness to help patrons that is when extreme customer service is achieved.

1/14/21 – Active Shooter – The active shooter webinar discussed the guidelines on how to respond during an active shooter situation. It first stated that an active shooter is an individual who is actively engaged in killing or trying to kill people in a public area. In most cases active shooter situations are unpredictable and then do not always have specific targets in mind.

After discussing what an active shooter is, the video then went into ways a person can be prepared for this situation. Such as, identifying escape routes nearby and having a plan in mind. Also, it stated that during an active shooter situation, a person must first identify the most reasonable place to protect their own life, such as hiding or evacuating the area (leaving belongings behind) and calling 911 and telling them the location of the shooter, how many weapons they have, number of potential victims, and any physical descriptions of the shooter.

The video also stated not to move wounded people, evacuating yourself whether other people are willing to follow or not, and always listen to the instructions of law enforcement officers. If evacuation is not possible, hiding is the best idea (especially locking or blocking off the door to the hiding place) and staying far away from the shooter. If a person is caught in the open and can not hide, their best option might be to try and overpower the shooter. Silencing cellphones is also a very important aspect to keep from giving your hiding spot away.

When law enforcement arrives, it is important to keep hands visible at all times, avoid making sudden movements, avoid pointing, no screaming and yelling, and put down any items.

1/14/21 – Readers Advisory Service – The Reader’s advisor is the vital link between reader and books and must be committed to serving patrons, sympathetic & nonjudgmental, approachable and

personable, must display appropriate body language, make eye contact, and smile. The advisor must also make and concerted effort to know patrons, what they like to read and notify them when new material comes in. The advisor needs to understand the appeal of a particular genre / author/ title.

Elements of Appeal or the “feel / fit” of a book:

- Frame ~graphic location, atmosphere, ambience
- Characterization ~ phoresic clues, motivation, development of protagonist, plot progress, characters thoughts
- Pacing ~ element that most readers can articulate, slow fast faster. “white space faster pace”
- Story line ~ what does the story emphasize, author’s intention, focus,
- what might limit its appeal

Objectives of the Readers Advisory Interview are as follows:

- What appeals to the reader
- How to get the reader to articulate the appeal
- How to conduct a readers advisory interview
- What books to SUGGEST
- How to promote the various genres

There are an overwhelming number or new titles and books on the library shelves, patrons get confused and need assistance.

1/22/21 – Assisting Patrons with E-Readers: Tactics and Troubleshooting – This workshop imparted basic information on how to use an e-reader. Two librarians, Jennifer Hrush and Megan Vasques, conveyed clear instructions for downloading and signing into an app and how to troubleshoot. They each provided simple tips for better assistance and customer service where our patrons are concerned, especially as many are still unaware on how to begin to use an e-reader with apps such as OverDrive and Hoopla.

1/23/21 – From Tots to Teens: STE(A)M-Powered Ideas for Programming – In this webinar I learned about incorporating STEAM into programing for kids and teens. The presenters, Heather Beverley and Heather Thompson offered awesome tips and ideas for programs that are inexpensive and fun. Even though the library currently cannot offer in-person events, I hope to add more STEAM concepts into our Story Time kits and potentially add STEAM programs or kits for school age kids and teens in the future.

Whether you're already full steam ahead with STE(A)M programming in your library or not sure how to get started or somewhere in between, there's something for you in this webinar. Our presenters—"The Heathers"—are passionate about creating engaging and skill-building STE(A)M programs for kids from preschool age to teenage. Find out what to look for in a good program and hear their top picks for programs for each age range. Learn some tips, tricks and useful resources. Get inspired—you don't need to be a scientist or engineer to have fun exploring and learning with the kids in your library.

1/25/21 – Outreach Services – Grab and Go: Expanding and Strengthening Senior Programming – This presentation was given by Outreach and Bookmobile librarians. There were some great ideas that I hope to try with some of the senior facilities once COVID ever goes away.

 - Patrons go on imaginary journeys to countries around the world
 - Include facts, folklore, ethnic spices, inflatable globe (that elderly patrons can easily hold), and use fun character voices and costumes
 - One-sided, Large Print booklet for each program to hand out to patrons to keep
 - Pass around "souvenirs," books, and photos for each travel adventure
- Memory Kits that focus on 1930s – 1950s eras
 - Comedians
 - Cooking
 - Country Singers (include cowboy hat, mini guitar, horse figurine, microphone, etc.)
 - Holidays (shamrocks, Mardi Gras beads, hearts, MLK book, ornaments, flag, turkey, etc.)

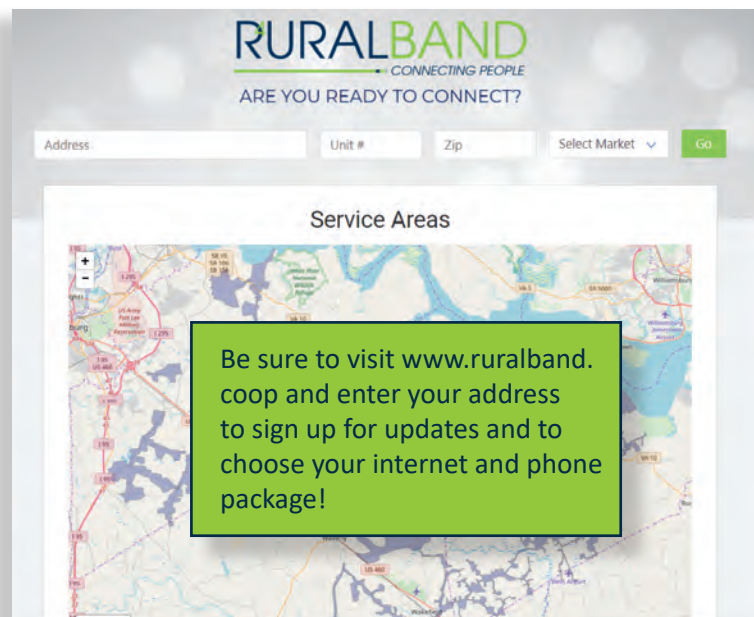
Funding Continues for the PGEC Fiber Build: Surry County was awarded in the form of a grant through the Virginia Telecommunications Initiative, \$2.25 million to provide broadband service to 1,253 homes. The VATI program is state-funded and administered by the Virginia Department of Housing and Community Development (DHCD). It provides targeted funding to extend service to areas that are unserved by a broadband provider and go to localities and broadband authorities to provide “last-mile” fiber to unserved communities.

In addition to the state VATI funding, PGEC Enterprises, LLC, received Connect American Funding (CAF) to deploy in all additional areas of Surry County. The completion of the FTTH project will mean all Surry residents will have broadband available to each home in the county.

A partnership has been formed with Dominion Energy Virginia to lease middle-mile fiber and they are currently deploying to support their operations. PGEC Enterprises, LLC, DBA RURALBAND will expedite the buildout to Surry residents by utilizing the middle mile fiber from Dominion.

Fiber Project Updates: PGEC understands that the need for high-speed internet is greater now than ever before. While the COVID-19 pandemic has certainly impacted the build by delaying the acquisition of certain materials, RURALBAND is diligently working to keep the project on target and to make sure members have access to important updates.

Phases of Fiber Construction

From start to finish, building fiber can take a year or longer.



1

Make-Ready Engineering

After an in-house design of the fiber build to the distribution access point, field engineers go to each pole to determine if any modifications are required in order to support the fiber, keeping in mind NESC clearance requirements.

2

Make Ready Construction

Line crews will change poles, move transformers from one side of the pole to the other, move wires on the pole, add new anchors to the poles, and perform other work to allow the fiber to be placed later.

3

Fiber Construction

Crews pull self-supporting cable as designed by the staking engineers and install distribution pedestals along the route to allow for service drops.

4

Splicing

Once the fiber is placed, splicers will make splices at each end and tap point. They splice the necessary cables at each point and mount the splices in enclosures secured to the distribution poles or in pedestals.

5

Service Drop Design and Construction

A staking engineer schedules a brief on-site meeting with each member to select the precise location for their service drop. This is a joint decision between the staking engineer and member, which takes into account both the preferences of the homeowner and feasibility from a construction perspective, taking into consideration any known, potential in-ground obstructions, such as water well or septic tank lines. This work can be done in parallel with some of the earlier work, or it might be done after the mainline fiber is in place. The drop crews install a fiber cable from the nearest splice point to the structure receiving service and leave coils of fiber in each location for the splicer to make appropriate connections.

Drop Splicing

The final outdoor step in fiber construction is the splicing of the drop. The splicer connects the last length of fiber at the distribution pedestal. The service is now ready to turn over to RURALBAND for service installation at the home.

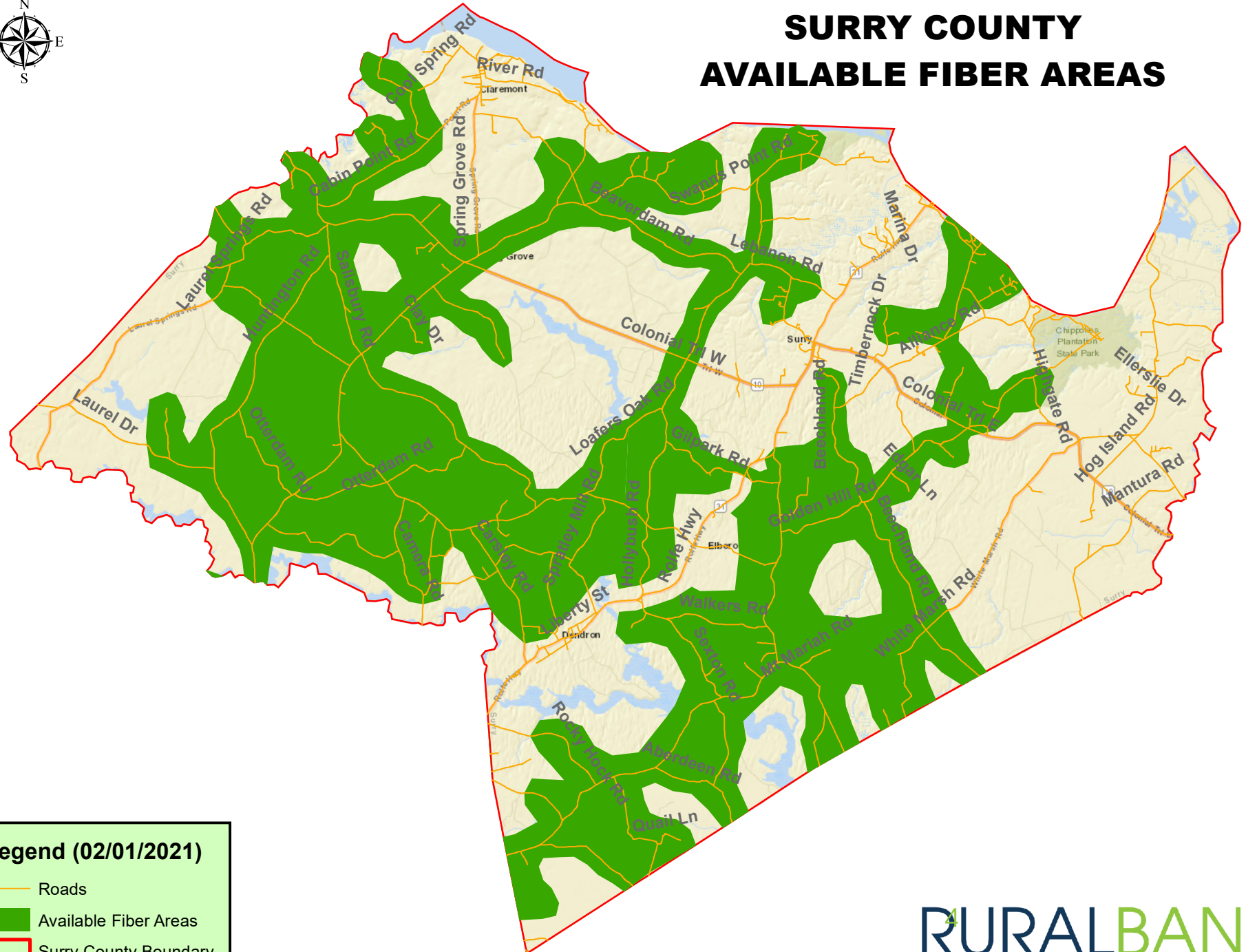

Service Point Installation and Final Turn-Up

On the day of installation, the install technician will bring the final length of fiber at the home into an indoor/outdoor demarcation closure at the previously determined location. They will then sleeve an armored fiber cable to the inside of the home, where the router will be mounted directly to the wall. At this point, the process is complete and the service is active.



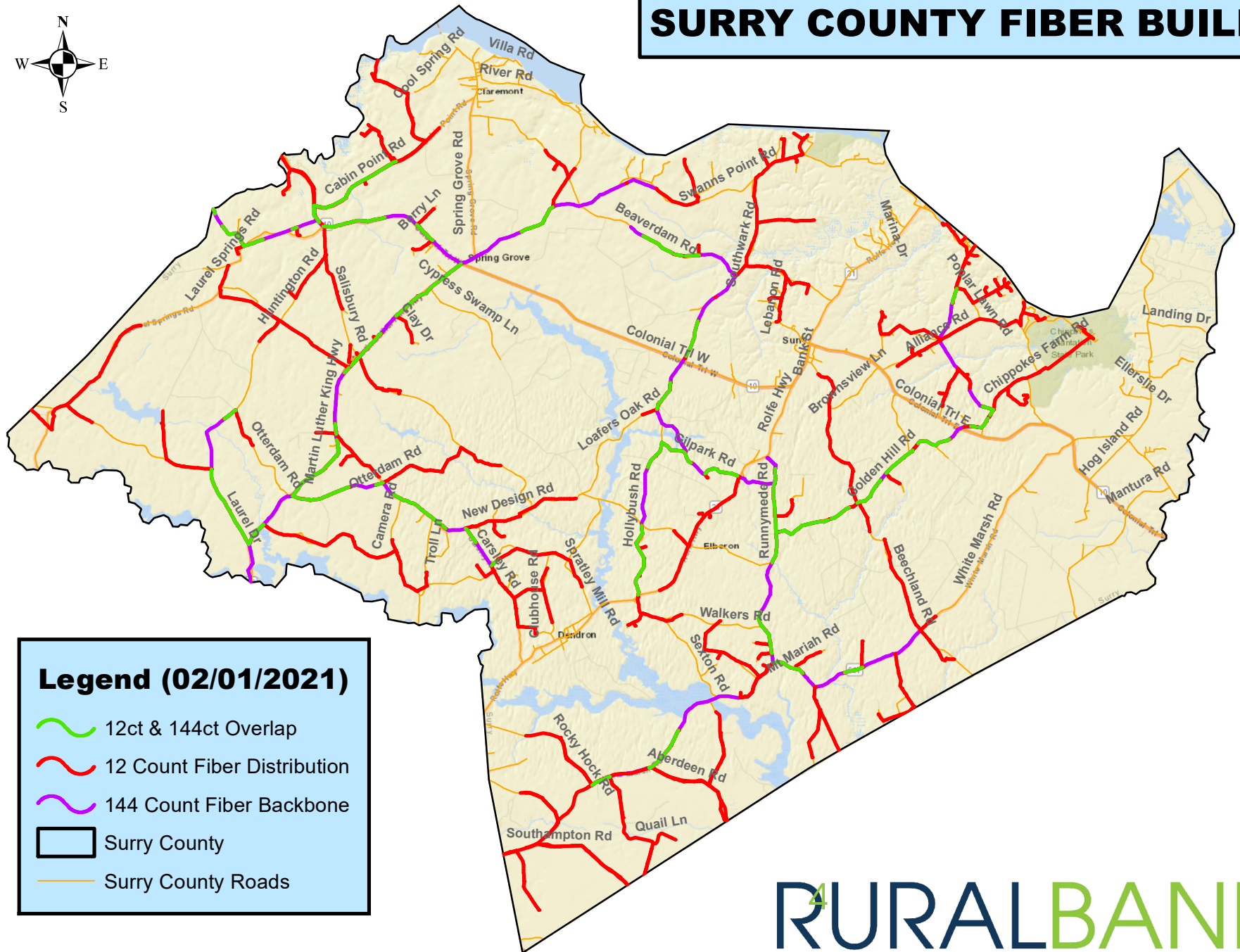
SURRY COUNTY AVAILABLE FIBER AREAS



Legend (02/01/2021)

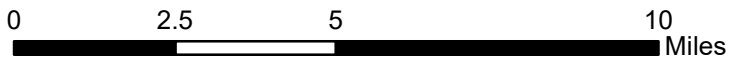
