## ORDINANCE 2025-04

### **AN ORDINANCE TO AMEND AND REORDAIN PART I – GENERAL ORDINANCES, CHAPTER 2 – ADMINISTRATION, ARTICLE III – OFFICERS AND EMPLOYEES, SECTION 2-85 TO ADD A SUBSECTION (c) AUTHORIZING THE BOARD TO GRANT EMPLOYEE BONUSES.**

- (1) **BE IT ORDAINED**, by the Board of Supervisors of Surry County, that Chapter 2, Administration, of the Surry County Code is hereby amended and reordained by amending Article III, Officers and Employees, Section 2-85, as follows:

#### **Sec. 2-85. – Compensation of county officers, employees and agents; disposition of fees.**

- (a) The chairperson and members of the board of supervisors and all other officers, employees and agents of the county shall receive as compensation for their services such sums as may be appropriated therefor in the annual budget or in other ordinances from time to time; provided, that persons serving under contract with the county shall receive such compensation as may be provided in this respective contracts; and provided further, that any person whose compensation is fixed by state law or by a body other than the board of supervisors pursuant to state law shall receive such compensation as fixed by state law or pursuant to state law.
- (b) Except as may be specifically provided otherwise by state law, this Code or other ordinance, all fees paid to county officers and employees for services rendered or documents furnished shall belong to the county and shall be paid into the county treasury by the recipients thereof not less frequently than once each week.
- (c) The board of supervisors, at its sole discretion and subject to appropriation, may authorize the county administrator to provide monetary bonuses to employees including qualifying individuals working under Constitutional officers, in such amounts and under such terms and conditions as the board may designate through adoption of a resolution. A "bonus" shall be defined as a lump-sum payment to an employee that is not part of the base salary.

- (2) That this ordinance shall take effect immediately.
